Basic Information

Message Sending - WhatsApp currently does not intend to use their platform for Promotional or Product

Information, Loyalty or Cross Selling messages.

Number Associated - Users can have more than one number associated with WhatsApp.

Authorization - WhatsApp provides a Verified Business Icon so that users know that this is a verified

account.

Encryption - All messages are end-to-end encrypted with WhatsApp.

Speed - A business can send 20 TPS per number per container.

Facebook Business - WhatsApp Business Verified account is provided on a Facebook Business Manager ID.

Process - Once WhatsApp Business is activated, we can deploy WhatsApp Docker, activate

number and send templates for approval.

Opt-In Guidelines

A business needs to obtain consent before pushing messages to its customers.

Opt-In modes could be Website, Mobile App, Email, SMS, Point-of-Sale and should meet the following guidelines...

I. User Triggered - A user must enter phone number or tick a checkbox on a visual element next to a

WhatsApp number & logo.

II. Clear Messaging - A user should clearly know the type of messaging & content they are signing up for.
